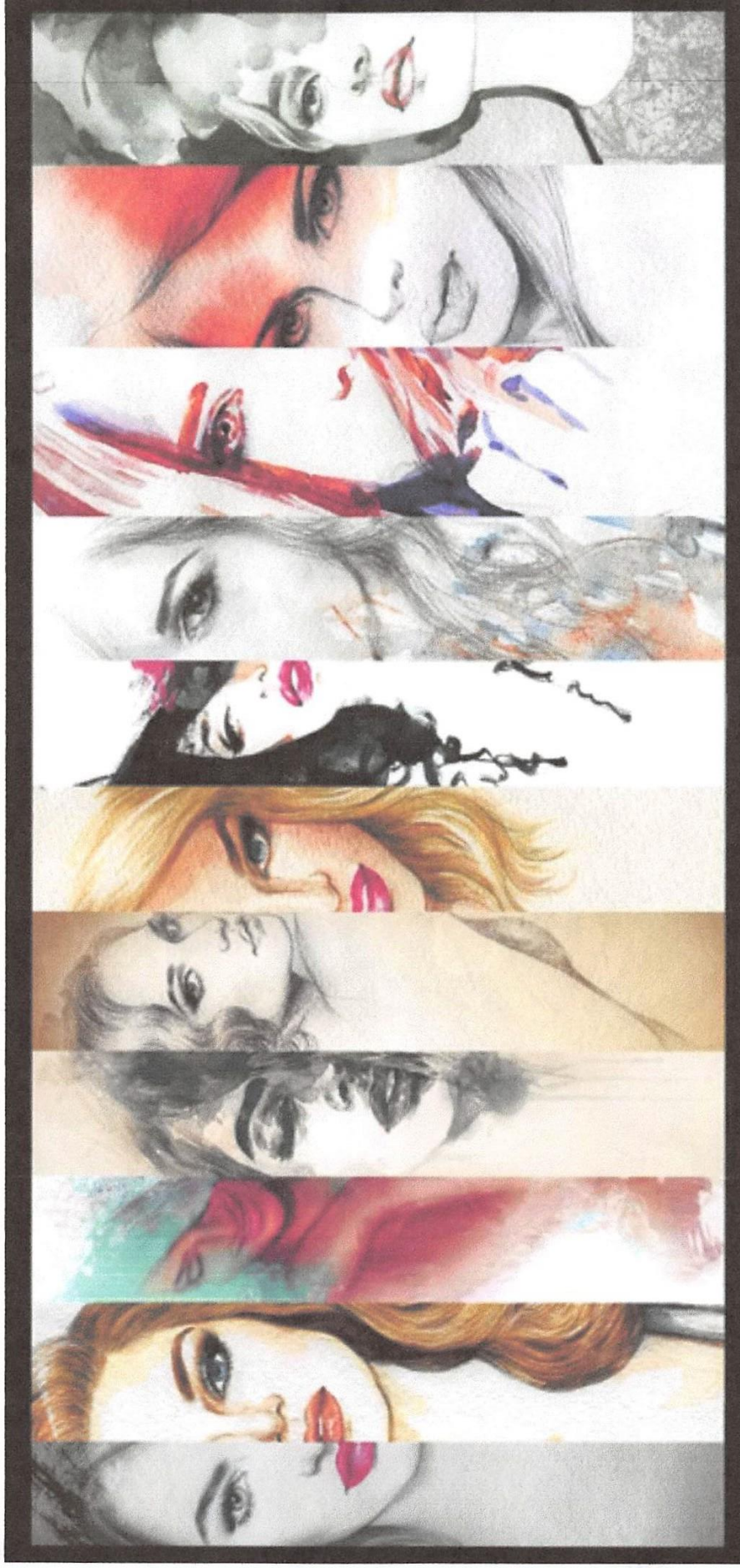

ENROLLMENT

Freshman classes begin January, March, June, August, October, and December. Information concerning exact dates can be obtained from the school office. Barrett & Co. reserves the right to start a class whenever one is necessary. Class scheduling is done with regard to teacher student ratio to maximize teaching effectiveness.

CERTIFICATE

Upon completion of either the Cosmetology, Nail Technology, or Apprentice Instructor Courses, the graduate is awarded a certificate stating the student has completed the educational and hourly requirements.

FACILITIES

Barrett & Co. School of Hair Design is located on South Main Street, in Kimberly Square Shopping Center, Nicholasville, KY. The school occupies 4,840 square feet of floor space on the ground level.

The location contains an offices, reception area, file room, clinic lab area, student lounge, classrooms, dispensary, stockroom, lockers and restrooms.

The clinic lab area is furnished with shampoo bowls and working stations where students work on customers under the direct supervision of an instructor. The classroom is equipped with student desks, television, DVD/VCR, visual aids; such as training videos, charts, chalkboard, power point and a Trico-analysis machine to aid students in the theory of cosmetology.

A private office is available to the faculty for interviewing and consulting students.

NOTICE OF ANNUAL SECURITY REPORT AVAILABILITY

Barrett & Co. School of Hair Design's annual security report is now available. This report is required by federal law and contains policy statements and crime statistics for the school. The policy statements address the school's policies, procedures and programs concerning safety and security, for example, policies for responding to emergency situations and sexual offenses. Three years' worth of statistics are included for certain types of crimes that were reported to have occurred on campus, in or on off-campus buildings or property owned or controlled by the school and on public property within or immediately adjacent to the campus. HOLIDAYS

UNIFORMS

Students wear black or khaki slacks, knee length walking shorts, or skirts, black shirts or sweat shirts imprinted with the school name and logo.

PLACEMENT

BARRETT & CO. SCHOOL OF HAIR DESIGN HAS A LICENSURE RATE OF 95% AND A PLACEMENT RATE OF 86%

Kentucky cosmetology regulations prohibit any Kentucky cosmetology school from guaranteeing employment or placement of their graduates. However, Barrett & Co. will counsel and advise all students concerning available employment and will assist graduates of Barrett & Co. to find employment any time during their careers.

TRANSFER STUDENTS

A student desiring to transfer to Barrett & Co. must notify the school in which he/she is presently enrolled of his/her withdrawal and must complete enrollment documents for Barrett & Co.

TRANSFERABLE HOURS

Any hours obtained in a program offered are transferable from or into another institution with the approval of the Kentucky State Board of Hairdressers and Cosmetologist. However hours are not transferable between programs.

SATISFACTORY ACADEMIC PROGRESS

Barrett & Co. satisfactory academic progress standards for students are based on two equally important factors: grade average and attendance.

1. Maintain a pace of attendance whereby each quarter (450 hours) grading period is completed in 17 weeks. (Part-time students are rated proportionately.)
2. Maintain a passing grade of 80% or better for each quarter (450 hours) grading period. CURRICULUM, ATTENDANCE POLICY, LEAVE OF ABSENCE, ACADEMIC PROBATION, GRADES and GRADING PERIODS, and RULES AND REGULATIONS are printed in the Barrett & Co. School of Hair Design Addendum, an official part of this catalogue.

Financial Aid Available For Those Who Qualify

COSMETOLOGY COURSE

The Kentucky State Board of Hairdressers and Cosmetologists require 1800 hours of instruction. The freshman portion of the course, or the first 300 hours of instruction, include lectures, demonstrations, and mannequin practice in, basic hairstyling fundamentals. These include dimensional design, pin curl and roller application and control, basic hair cutting techniques, chemical services, including; permanent waving, relaxing and color, and manicuring and facials.

As an intermediate, the student is introduced to the clinic lab where h/she works on patrons and exercise the knowledge gained during the freshman course. (It is only through applied knowledge that the necessary experience and comprehension of cosmetology by highly specialized experts in our profession.

Upon completion of the course (with satisfactory progress) the student will be required to pass an examination given by the Kentucky State Board of Cosmetology to receive an Apprentice Cosmetology License.

ADMISSION REQUIREMENTS

- High School Diploma/GED
- 16 years of age or older

NAIL TECHNICIAN COURSE

The length of the Nail Technician Course is 600 hours, and is designed to train individuals the skill necessary for performing manicuring services. The course covers techniques such as artificial nail applications, nail shaping, color selection and polish application, care and condition of the nail, massage of the hand and arm, and business management.

Upon completion of the course, the student will be required to pass an examination given by the Kentucky State Board of Cosmetology to receive a nail technician license.

ADMISSION REQUIREMENTS

- High School Diploma/GED
- 16 years of age or older

APPRENTICE INSTRUCTOR

The course of study is 1000 hours and includes psychology of student training, lesson planning, demonstration techniques, classroom management, and teacher assistance. An apprentice instructor will be under the supervision of a licensed cosmetology instructor. Upon completion of the course, the student will be required to pass an examination given by the Kentucky State Board of Cosmetology to receive a Cosmetology Instructor License.

ADMISSION REQUIREMENTS

- High School Diploma/GED
- One Year as a licensed cosmetologist

BRUSH UP CLASSES

Brush up classes are offered to the alumni of the school and licensed Cosmetologists. These classes are designed to keep the cosmetologist abreast of the ever changing hair fashion scene. Information on brush up classes is available on request from the school. Kentucky State Board of Hairdressers and Cosmetologist determines the certification of additional hours.
